The Board of Control of the Kentucky High School Athletic Association met at the Phoenix Hotel, Lexington, on Saturday morning, December 18, 1954.

The meeting was called to order by President Carlos Oakley at 10:00, with Directors Russell Williamson, James L. Cobb, Louis Litchfield, Roy G. Eversole, W. H. Crowds; Commissioner Theo. A. Sanford and Assistant Commissioner J. B. Mansfield present.

Roy G. Eversole moved, seconded by Louis Litchfield, that the reading of the minutes of the October meeting be waived since the members of the Board had received copies of these minutes. The motion was carried unanimously.

President Oakley called for a report from the Building Committee, and Chairman James L. Cobb made the report. Mr. Cobb stated that Ball & Co. had accepted the Board's offer in the amount of \$18,000.00 for a lot, located on the west side of Rose Street between South Limestone Street and Washington Avenue in Lexington; that a binder of ten per cent of this amount had been paid to Ball & Co., and that the remainder of \$16,200.00 would be paid to complete the transaction upon authorization by the Board of Control. The Board also discussed the various preliminary sketches which had been presented to the Board members present at a meeting of the Building Committee held the preceding evening.

James L. Cobb moved, seconded by Russell Williamson, that the Building Committee be authorized to complete the purchase of the lot from Ball & Co., on which a binder had been given, at a price of \$18,000.00, and that the Secretary-Treasurer be authorized to pay Ball & Co. the balance of \$16,200.00 due, prior to January 1, 1955. The motion was carried unanimously.

Roy G. Eversole moved, seconded by Russell Williamson, that Meriwether & Marye be employed as architects and supervising engineers for the K.H.S.A.A. office building at the usual fee of six per cent, and that the Secretary-Treasurer be authorized to sign a contract with these architects. The motion was carried unanimously.

Louis Litchfield moved, seconded by W. H. Crowds, that the Building Committee be authorized to employ legal council at its discretion, and that the Committee be empowered to direct the President to call a meeting of the entire Board when necessary. The motion was carried unanimously.

President Oakley vacated the chair and asked Secretary-Treasurer Sanford to preside. Carlos Oakley moved, seconded by Russell Williamson, that the Building Committee be empowered to proceed with the planning and erection of an office building, herein referred to as K.H.S.A.A. Building--Alternate Scheme A, as presented by the Building Committee. The motion was carried unanimously.

The Commissioner read the Constitution and By-Laws of the proposed Kentucky Federation of High School Girls' Sports Associations, recently presented to him by Dr. Martha G. Carr, Head of the Women's Division of the University of Kentucky Department of Physical Education. Upon the recommendation of the Commissioner, Roy G. Eversole moved, seconded by Russell Williamson, that the Board of Control give its approval to the Kentucky Federation of High School Girls' Sports Associations, that magazine space be made available for publicizing the organization, and that the current budgetary figure for the NSWA be increased from \$200.00 to \$500.00. The motion was carried unanimously.

The Commissioner presented a request from Coach Oren Webb of the Kyrock High School concerning the restoring of the eligibility of Donavon Meredith, a student at the Kyrock High School. It was stated that Meredith, a former Kyrock student, had enrolled and attended school at the Fern Creek High School for approximately one month during the current semester, having moved to the Louisville area with his parents, and that he had subsequently returned to Kyrock and re-enrolled there, living with a relative. It was the opinion of all Board members that Meredith had severed his connection with the Kyrock High School, as far as eligibility is concerned, when he moved to the Louisville area with his parents and was enrolled at the Fern Creek High School for as long as one month. The Board declined to restore Meredith's eligibility at the Kyrock High School.

The Commissioner read a request of Prin. Robert L. Pay of the Eminence High School concerning restoring the eligibility of Emmitt True and Bobby Johnson at the beginning of the second semester of the current school year. Mr. Pay stated that True and Johnson would become eligible scholastically at the beginning of the second semester, but that they had taken part in one or more independent basketball games at the beginning of the current semester before they realized that they might make themselves ineligible during the 1954-55 season by so doing. James L. Cobb moved, seconded by Russell Williamson, that the eligibility of Emmitt True and Bobby Johnson of the Eminence High School be restored as of the beginning of the second semester of the 1954-55 school year. The motion was carried unanimously.

There was a discussion concerning the naming of a speaker for the forthcoming annual dinner meeting of the K.H.S.A.A. The Commissioner was authorized to attempt to secure the services of Commissioner L. V. Phillips of Indiana for the annual dinner meeting of the Association.

James L. Cobb moved, seconded by Russell Williamson, that all bills of the Association beginning October 9, 1954, and ending December 17, 1954, be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as Board of Directors of the K.H.S.A.A. Protection Fund.

The Secretary-Treasurer reported a request from Coach Delbert Walden of the Williamstown High School concerning a proposed claim of Charles G. Glass. This boy had been examined for insurance on October 11, and was injured on October 12, prior to the time when the Williamstown summary sheets were mailed to the K.H.S.A.A. office on October 13. Previous Board policy had been that insurance is not considered in effect until the list of players is placed in the mail. The members of the Board thought that this policy was sound, and that it should not be changed.

Secretary-Treasurer Sanford presented a list of claims which had been paid by the Protection Fund since October 9, 1954, the total amount of these claims being \$7,335.71. Roy G. Eversole moved, seconded by Louis Litchfield, that the claims as presented by the Secretary-Treasurer of the Protection Fund be allowed, and that a list of these claims be made a part of the minutes of the meeting. The motion was carried unanimously. The claims are as follows:
