Sports Safety Work Group Final Report Garners Praise from Education Committee

Members of the Interim Joint Committee on Education praised members of the Sports Safety Work Group for its thorough report and expedient implementation of the Sports Safety Course during a regularly scheduled meeting of the Committee on Monday in Frankfort.

More than 8,150 coaches have completed the Sports Safety Course as of Nov. 9. In response to House Bill 383, which was signed into law by Gov. Steve Beshear on March 25, the seven-module course was developed with the assistance of the Kentucky Medical Association in little more than eight weeks and became available on July 2. At least one coach who has completed the course must be present at every practice or competition during the 2009-10 school year; in 2010-11, successful completion of the course becomes a requirement for all high school coaches, and a condition prior to the hiring of new coaches.

As defined by the legislation, the course content will be updated at least every 30 months. The online nature of the course will make curriculum updates easier, according to KHSAA Commissioner Brigid DeVries. "We tried to build it for the future," DeVries told the Committee.

The course has also gained national attention for its content and accessibility. Dr. James "Pete" Bowles, who helped design the curriculum, said the program is unique. "Kentucky is viewed as a leader in this area," Bowles told the committee. "This is the only course that's online in the entire country."

The Sports Safety Work Group, a 22-member panel was comprised of medical professionals, certified athletic trainers, educators and coaches stipulated in the language of House Bill 383, and met seven times over the course of five months. The SSWG examined every aspect of sports safety as it related to student-athletes at Kentucky's secondary schools. The final report, a 765-page document, included all of the material reviewed by the group, highlighted by eight SSWG recommendations in an effort to further strengthen sports safety and risk minimization for Kentucky's student-athletes.

"Special thanks are in order to all individuals who contributed to the final SSWG report," DeVries said. "The SSWG was an example of a great collaborative effort."

STATE CROSS COUNTRY THIS WEEKEND

The 2009 KHSAA State Cross Country Championships are scheduled for this Saturday, Nov. 14 at the Kentucky Horse Park in Lexington. Action begins with the Girls' Class A race at 9:30 and concludes with the Boys' Class 3A race at 2:15 p.m.
